During this fiscal year, Avenues for Homeless Youth opened a second site-based shelter and transitional housing program to support homeless youth ages 16-21 from the northwest suburbs of Hennepin County. This program opened in early February 2015 and is known as Brooklyn Avenues.

With the opening of Brooklyn Avenues, about 250 homeless young people are now provided shelter, transitional housing and supportive services every year through Avenues' five programs. The vast majority (83%) of youth who access our programs are youth of color.

The GLBT Host Home Program supported 13 young people during 2014-15. Of the youth who moved out of their host homes during the year, 100% moved into stable living arrangements upon move out or shortly after with support of our case manager. Avenues continues to expanded its commitment to case management support for the youth in host homes, as well as on an after-care basis after they have moved out of their host home. In addition, our case manager connects with and supports homeless GLBT youth who are not living in a host home, but need help navigating systems and barriers. This program had \$101,202 in total expenses for 2014-15.

The Minneapolis and Suburban Host Home Programs supported 10 youth during

The mission of Avenues for Homeless youth is to provide emergency shelter, short term and transitional housing and support services for homeless youth in a safe and nurturing environment. Through such service, Avenues seeks to help youth achieve their personal goals and find a positive transition into young adulthood.

In early 2015, Avenues for Homeless Youth opened a second site-based shelter and transitional housing program, known as Brooklyn Avenues. This new program supports 12 youth at a time ages 16-21 from the northwest suburbs of Hennepin County. Youth receive all basic needs (bedroom, bath, 3 meals/day, supplies, laundry, bus passes, access to computers and phone), 24 hour guidance and support from staff, and a full range of supportive services designed to address their needs and help them pursue personal goals for education, employment, health and wellness, life skills and stable housing. We anticipate this program will support 80 to 100 youth every year.

the 67 youth who exited during this timeframe, 24% moved in with family and 31% moved into a stable housing arrangement. Another 50 youth continued to receive support from Avenues after moving out through our After-Care programming. This support helps the youth remain stable or increase their stability, continue learning life skills and work through challenges. This program had \$123,198 in total revenue and \$925,160 in total expenses for 2014-15.

Brooklyn Avenues (Brooklyn Park) supported 39 young people during its first 5 months of operation (February through June 2015). Of those, 25 lived in the program and 14 used the emergency bed for at least one night. Of the 15 youth who had moved out during the first 5 months, 47% moved in with family, 27% moved into a stable housing arrangement and 26% were in an unstable situation. This program had \$26,773 in total revenue and \$284,312 in total expenses for 2014-15.
