**During fiscal year 2015-16, Avenues for Homeless Youth provided shelter, transitional housing and comprehensive support services to 319 youth experiencing homelessness during the fiscal year. It continued operating five programs and launched a sixth program, the ConneQT Host Home Program, in March 2016. Youth supported are disproportionately youth of color.**

**Avenues' program accomplishments during 2015-16 include the following:**

**Minneapolis Avenues (North Minneapolis) supported 188 youth experiencing homelessness. Of those, 88 youth lived at Avenues and**

**The GLBT Host Home Program supported 15 young people who identified as lesbian, gay, bisexual, transgender or queer (LGBTQ) and were homeless. Of the 10 youth who moved out of their host homes during the year, 90% moved into stable living arrangements. Our case manager also connects with and supports homeless LGBTQ youth who are not living in a host home, but need help navigating systems and barriers.**

**The Minneapolis and Suburban Host Home Programs supported 7 youth. Of the youth who moved out of their host homes during the year, 80% moved into stable living arrangements. Youth participants are from the City of Minneapolis and the suburbs of Hennepin County.**
